Dear Sir/Madam,

At the outset, I would like to congratulate and thank you for your cooperation in successful conduct of 2nd Term End Examination for Diploma in Elementary Education (D.El.Ed.) conducted by NIOS in September, 2018 for training the in-service untrained elementary teachers. In continuation, the 3rd Term End Examination for the courses 506 & 507 is scheduled to be conducted on 20th and 21st December, 2018.

2. The datasheet for conduct of 3rd Term End Examination of D.El.Ed. has already beencirculated and uploaded on D.El.Ed portal vide NIOS Notification No. 29/2018 dated 24th October, 2018. Around 12 lakh teachers have been registered for the 3rd phase of the examination.

3. In this regard, the detailed Standard Operating Procedure (SOP) for the conduct of examination has already been circulated during the May-June 2018 examination and is available at NIOS's D.El.Ed portal. In order to ensure the smooth and fair conduct of examination, it is essential that the procedure laid down in the SOP is followed in letter and spirit.

4. The examination would be conducted at the examination centres earlier notified by the States/UTs. The State Nodal Officer may be requested to keep in touch with NIOS, in case any change is required in the establishment of examination centres.

5. Further, as intimated during the conduct of May-June 2018 examination, the concerned District Magistrate, after seeking consent, have been made the Custodian of Question papers. The custodians may also be requested to take responsibility of the safe custody of Question Papers and also timely delivery of the Question Paper packets to the identified Examination Centres in their respective district under their jurisdiction. In case of any change in the name and addresses of the custodians, the State Nodal Officer may be requested to intimate to the NIOS HQs within a week.

6. I would appreciate, if necessary instructions are issued to the concerned officers of your State/UT to ensure the sanctity and secrecy of the examination.
